



DEEPAVALI ANGPAU 2021 TERMS AND CONDITIONS

A. BASIC TERMS

1.	Organiser	MEASAT BROADCAST NETWORK SYSTEMS SDN BHD (Company No. 199201008561 (240064-A))
2.	Name of Contest	'Vinmeenin Deepavali Angpau 2021'
3.	Brief Description of Contest/ Programme	In conjunction with Deepavali 2021 celebrations, Astro Vinmeen ("Vinmeen") offers its viewers a 'Call and Win' format contest show ("Contest"). This Contest consist of 10 segments running for two (2) days between 4 th and 5 th November 2021 with each segment at 5 minutes duration. The Contest will be broadcast LIVE on Vinmeen Channel 202 on the first day of Deepavali (4 th November 2021) and on second day of Deepavali (5 th November 2021). Vinmeen viewers who succeed to call in must provide correct answers to questions posed in each segment. The winning prize for each segment is RM1,000 for every 2 questions answered correctly. The total cash prize to be won is RM10,000 subject to the terms and conditions of the Contest.
4.	Brief mechanism of Contest	<p>The Contest has 10 LIVE segments divided into two (2) days, i.e. 5 segments for Day 1 on 4th November 2021 and 5 segments for Day 2 on 5th November 2021 (each a "Segment"). Only the 1st Segment on Day 1 will be 10 minutes in duration whereas the rest of the Segments will be 5 minutes in duration minutes duration each.</p> <p>Each Segment will have 2 questions. Questions will be based on Vinmeen programme line up for Deepavali 2021. Vinmeen viewers who succeed to call in must provide correct answers to the question in the respective Segment.</p> <p>The Organizer will only permit two (2) callers ("Callers") to call-in during each Segment of the Contest. Each Caller will be required to answer 1 question correctly within 30 seconds in order to win RM500.</p> <p>In each Segment, viewers must call in to an allocated phone number [Contact Number 1] for initial verification of caller's details e.g. name and contact number ("First Call"). Once verified, the Organizer' will then contact the caller(s) in the First Call from [Contact Number 2] ("Second Call"). During the Second Call, the caller will be permitted to go LIVE onto the Contest. Any caller who is uncontactable by the Organizer within a duration of 5 minutes from the Organizer's attempt of the Second Call shall be deemed to be unreachable and uninterested to participate in the Contest. No further appeals will be allowed under such circumstances.</p> <p>If the Caller fails to remain on the Second Call to answer the question during the LIVE question and answer session in the applicable Segment, the Host will end the Segment and move to the next segment. No appeals will be entertained by the Organizer if such a situation occurs.</p> <p>In any event, the number of questions and callers allowed to answer in each Segment shall remain as two (2), unless otherwise varied by the Organiser at its sole discretion.</p> <p>For avoidance of doubt, Caller(s) who have won the cash prize of RM500 for a question in a segment are NOT allowed to call in again to participate in following Segment(s) of the Contest.</p> <p>In the event any questions are not answered correctly or remains unanswered, the amount of RM500 will snow-ball to the next set of questions for a new Caller. For example, if the 1st question is not answered correctly,</p>

		<p>the prize money of RM500 will snow-ball to the 2nd question, accumulating to RM1,000 so on and so forth.</p> <p>Every question in each Segment will be new and there will be no repeat nor carry-forward of same question to any of the Segment(s).</p> <p>If there is any balance of the prize money from the last segment in Day 1 of the Contest i.e. on 4th November 2021, that balance sum will be brought forward into Day 2 of the Contest, i.e. 5th November 2021.</p> <p>The Terms and Conditions, Standard Terms and Privacy Notice (“T&C”) will be uploaded prior to the date of the Contest on www.astroulagam.com.my website. Vinmeen viewers who wish to participate in the Contest are deemed to have read and understood the T&C before participation. The Organizer has the right to disqualify any caller(s) who fail to comply with this requirement.</p> <p>Every caller who participates in the Contest must give his/her personal details e.g. Full Name as per their NRIC and Contact Number for the Organizer to reach him/her should the successful caller become a winner (“Winner”) at the end of each LIVE segment.</p> <p>After each Segment, the Organizer will contact the Winner to verify his/her Name and NRIC and obtain additional details e.g. Email Address and Bank Account Number (first page only) for remittance of cash won during the Contest. Winner(s) are required to provide copy(s) of NRIC and Bank Statement (first page only) to the Organizer for verification and remittance purposes within fourteen (14) days of the Contest Period.</p> <p>The Callers must adhere to the Mechanism and other terms and conditions of the Contest as may be notified or communicated by the Host during the Contest Period.</p>
5.	Eligibility Criteria	<ul style="list-style-type: none"> ● Malaysian citizens only irrespective of age. ● Minors below 18 years of age as of 1st January 2021 shall require the consent of legal guardian/parent. ● Tamil speaking.
6.	Ineligibility	<p>Employees and scholars of Astro Malaysia Holdings Berhad and its Group of Companies and their *immediate family members.</p> <p>* “immediate family members” mean spouse, children, parents, brothers and sisters.</p>
7.	Age of Eligibility	As Item 5 above
8.	Charges	Not Applicable
9.	Contest Period	<p>4th November 2021 and 5th November 2021</p> <p>TIME SLOTS TO BE ADVISED. EACH SEGMENT WILL BE SLOTTED AT DIFFERENT INTERVALS.</p> <p>The Organiser reserves the right to vary, postpone or re-schedule the Contest Period or any dates thereof at its sole discretion.</p>
10.	Language of Contest	Tamil

11.	Entry Procedure	<p>To participate, please do the following:</p> <ol style="list-style-type: none"> (1) read the Terms and Conditions and Privacy Notice as made available on the Organiser's website at www.astroulagam.com.my; (2) call in on the day of Contest Period via telephone number [Contact Number 1] provided by the Organizer and displayed on the Organizer's platform; (3) answer each question correctly within 30 seconds from the time the question is posted by the Host; and (4) must provide his/her Full Name and Contact Number upon the initial call [Contact Number 1] to the Organizer's representative. Failure to do so will automatically disqualify the intended caller from participation in the Contest. <p>The Organiser shall be entitled to request copies of Identity Card and Bank Statement (first page only) of parent/s including other supporting documents in the case of minors ("Minors") participating in this Contest for verification and remittance purposes in the event the said Minor wins any cash prize in the Contest.</p>

Collection Period	<p>Winner(s) are required to submit the following to the Organizer within fourteen (14) days of the Contest Period for verification and to proceed with remittance of prizes won in the Contest:</p> <ul style="list-style-type: none"> ● Those above 18 years of age as of the Contest Period must provide copy(s) of NRIC and Bank Statement (first page only); ● Minor(s) below 18 years of age as of 1st January 2021 must provide copy of MyKid, Parent(s) NRIC and Bank Statement (first page only). <p>Failure to provide any of the abovesaid documentation within the stipulated timeline may lead to forfeiture of the Prize by the Organizer at its sole discretion.</p> <p>The Organiser's decision will be final and no queries and/or appeals will be entertained in such situation(s).</p>
