A. BASIC TERMS

3.	Brief Description of Contest/ Programme	This Contest is held in conjunction with “XUAN Pattern Gao-Gao Fan 丝奖”, a local produced web variety show by XUAN on http://www.xuan.com.my/tvbawards2018
4.	Brief mechanism of Contest	To participate in the Contest, eligible contestants are required to log on http://www.xuan.com.my/tvbawards2018 to vote their favorite nominees via the Entry Procedure per Clause 11 below and vide the prescribed Mode at the designated Address by the stipulated Entry Deadline as set out in the respective Clauses 13, 14 and 12 below. The Contestants must adhere to the mechanism of the Contest as may be notified or communicated by the Organiser during the Contest Period.
5.	Eligibility Criteria	Subject to other criteria set out below and in the Contest Standard Terms and Conditions, the Contest is open to all Malaysian citizens of the Age of Eligibility below.

9.	Contest Period	From 26 November 2018/ 12am to 7 December 2018 / 12pm The Organiser reserves the right to vary, postpone or re-schedule the Contest Period or any dates thereof at its sole discretion.

Vote your favorite nominees maximum 3 votes per category per day . .</p> <p>The Organiser shall be entitled to request to sight the original Identity Card or the originals of other supporting documents/materials for verification and validation.</p>
12.	Entry Deadline	<p>Entries must be received by the Organiser on or before 07 December 2018 @12pm.</p> <p>Entries received before the commencement of the Contest Period and after the stipulated Entry Deadline will be disqualified and ineligible for consideration for prizes.</p>

18.	Collection Period	<p>The Winner must provide the Organiser and/or its appointed travel agency at least three [3] days prior notice for his/her intention to travel.</p> <p>Prizes not collected within the stipulated period will be forfeited.</p>
19.	Collection Venue	To be arranged between the Organiser and Winner.

However, each Contestant can only submit their entry once each day during the Contest Period and will be allotted three (3) votes only per category. However, each eligible Contestant is only entitled to one (1) Prize throughout the Contest Period.</p>
